

1) Organizer

The organizer of the VOICINGERS Festival (hereinafter referred to as the Festival) is START! 3) Time and location of the Festival

The festival will be held in Frederiksberg and Copenhagen on August 26-28, 2022.
The festival facilities will be: HUSET-Kbh and Musikhøjskole Frederiksberg

4) Festival Programme

The festival consists of:

- a / concerts, scheduled for August 26-28, 2022
- b / workshops, planned on August 26-28, 2022
- c / jam sessions, scheduled for August 26-27, 2022
- d / final concert of the workshops, planned for August 28, 2022

5) Concerts (tickets):

a / Tickets for paid Festival events are sold for the entire evening, not for individual concerts taking place on a given day. The organizer reserves the right to change the order of performances on a given day. Tickets can be purchased from the Organizer (via billetto.dk) no earlier than (..) days before the beginning of the Festival. This deadline may be separately shortened by the Organizer. The organizer does not accept ticket returns.

b / Workshop participants, people acting on behalf of the Organizer, artists working at the festival and invited promoters are entitled to free admission to concerts. Organizer allocates 4% of the maximum number of participants for dissemination to vulnerable citizens in connection with paid concerts.

6) Workshops

a / Participation in each of the workshops is voluntary, but attendance in all classes, concerts and jams is a prerequisite for the full experience of the Festival, which is the fullness of Voicingers Experience.

b / The organizer reserves the right to remove the participant from one or more workshops

Who violates the principles of social coexistence and / or good manners, and / or the regulations of the facilities festival and / or safety rules

c / Reimbursement of any unused amounts related to the participation of a person removed from the workshop will take place on the basis of generally applicable law.

7) Jam sessions

Punctual attendance to classes is the responsibility of the workshop participant. Jam Sessions is for workshop participants nothing else than evening classes. The Music Night starts at 22:00 and finishes at 2:30. Jam Sessions is a time and opportunity to play your repertoire, to make friends with musicians preparing for the performance. Participation in them is obligatory, punctuality is recommended, and the use of the jam scene from the very first day is recommended and welcomed.

8) Final concert of the workshops

Performance in the final concert for Participants is not obligatory. People who want to take part in it should report it no later than on the second day of the workshops.

9) Registration

a / The deadline for applications for participation in the workshops is August 23, 2022.

b / The application should be made by submitting a form on voicingers.com/dk website

c / Any arbitrary changes to the application form with attachments are not allowed.

d / Sending the application form is equivalent to accepting the content of it without reservations of the Regulations.

10) Costs of participation in workshops and payment rules

a / all payments should be made in cash at the Organiser's cash desk or by transfer to a bank account Organizer, details below.

b / To complete the registration process after submitting the form, participants are obligated to transfer 600 DKK (accounting for 50% of the cost of participation in the Festival) within three days to:

The rest (600 DKK - accounting for the remaining 50% of the participation cost in the Festival) should be paid until three days before the Festival starts or by cash at the Festival desk on the first day.

11) Conditions of participation in the festival:

a / qualification for participation in the Festival by the Organizers.

Due to the artistic nature of the festival, the negative decision of the Organizers does not require a justification and does not serve its appeal.

b / making a timely application in accordance with the requirements of these Regulations.

c / timely payment of fees in accordance with these Regulations.

d / The minimum age required is 16 years.

12) Special Rules of the Festival

a / Festival participants are required to use works, artistic performances and phonograms with respect for any copyright or related rights of their authors, performers, manufacturers etc.

b / The Organizer informs that the course of the Festival may be recorded and then promoted with using all known methods / channels, including audio and / or video recording

c / Participants take part in the Festival at their own risk. The organizer is exempt from liability for damages to the fullest extent provided for by law.

d / The Organizer is entitled to change the Festival plan and the Regulations.

e / The organizer does not provide reimbursement, in particular costs of travel, meals, drinks, accommodation, etc. for participation in the Festival. The organizer does not provide awards.

13) Attachments

Attachments to the Regulations are: the application form with the GDPR clause as well as consents and declarations.

14) Personal information

The Festival does not disclose any personal data or other information entered on this website to any third party. The personal data is collected for the purpose of handling registration and payment from participants of the festival and to contact you with relevant information regarding the Festival

15) Photos and video.

By attending the Festival participants consent to appearing in photos and videos taken during the festival. These photographs may be used for promotional purposes by Voicingers and will not be disclosed to any third party without the permission of Voicingers.
